This statement is the responsibility of the Company's management and has been approved by the Board of Directors of the Company. Our responsibility is to issue a report on the Statement based on our review.
- 2. We conducted our review of the Statement in accordance with the Standard on Review Engagements(SRE) 2410, 'Review of Interim Financial Information Performed by the Independent Auditorof the Entity' issued by the Institute of Chartered Accountants of India. This standard requiresthat we plan and perform the review to obtain moderate assurance as to whether the Statementis free of material misstatement. A review is limited primarily to inquiries of companypersonnel and analytical procedures applied to financial data and thus provides less assurancethan an audit. We have not performed an audit and accordingly, we do not express an auditopinion.

Independent Auditor's Review Report on consolidated unaudited quarterly financial results of Super Tannery Limited Pursuant to the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

The Board of Directors of Super Tannery Limited

- 1. We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results of Super Tannery Limited ("the Parent") and its subsidiaries (the Parent and its subsidiaries together referred to as "the Group") for the quarter ended June 30, 2020 ("the Statement"), being submitted by the Parent pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended.
- 2. This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurementprinciples laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India. Ourresponsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. A review of interim financial information consists of making inquiries, primarily of persons responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33 (8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, to the extent applicable.

- 4. The Statementincludes the results of the following subsidiaries:
 - Super Tannery (U.K.) Ltd.
 - ii) Super Italia SRL
 - iii) Aarifi Tanners Ltd
 - iv) Super Corporation Ltd
 - v) Secure Safety Ltd
- 5. Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the review reports other auditors referred to in paragraph 6 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standards and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the mannerin whichit is to be disclosed, or that it contains any material misstatement.



- 6. We did not review the interim financial results of three subsidiaries included in the consolidated unaudited financial results of the group, whose interim financial results before consolidation eliminations reflect total revenues of Rs.0.08 Lacs, total net profit after tax of Rs.(-)0.05 and total comprehensive income of Rs.(-) 0.05 Lacs, for the quarter ended 30th June 2020, as considered in the consolidated unaudited financial results. These interim financial results have been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries is based solely on the reports of the other auditors and the procedures performed by us as stated in paragraph 3 above.
 Our conclusion on the Statement is not modified in respect of the above matters.
- 7. The Statement includes the interim financial result of two subsidiaries which have not been reviewed, whose interim financial results before consolidation eliminations reflect total revenue of Rs.301.84 Lacs, total net profit after tax of Rs 3.56Lacs and total comprehensive income of Rs 3.56 Lacs for the quarter ended June 30, 2020, as considered in the statement. According to the information and explanations given to us by the management, these interim financial results are not material to the Group.
 Our conclusion on the Statement is not modified in respect of the above matter.
- 8. We draw attention to Note no.5 of the Statement regarding impact of COVID-19 pandemic on the operations of the Company.

Our conclusion is not modified in respect of this matter.

- The Company is primarily engaged in the manufacture and sale of leather and leather products. There is no separate reportable segment as per IndAS 108, "Operating Segment".
- During the Quarter ended June 30, 2020 company's operations were affected due to lockdown announced on account of COVID-19, pandemic by State/Central Government. This has impacted financial performance of the company. The company has analysed all the relevant parametres associated with the risk due to pendamic COVID-19 and is of the opinion that it will not have any material impact on the recoverability of the carrying value of its assets at June 30, 2020 and going concern assumption.
- Figures for the previous period are re-classified / re-arranged / re-grouped where ever necessary, to correspond with the current period periods classification / disclosure.
